

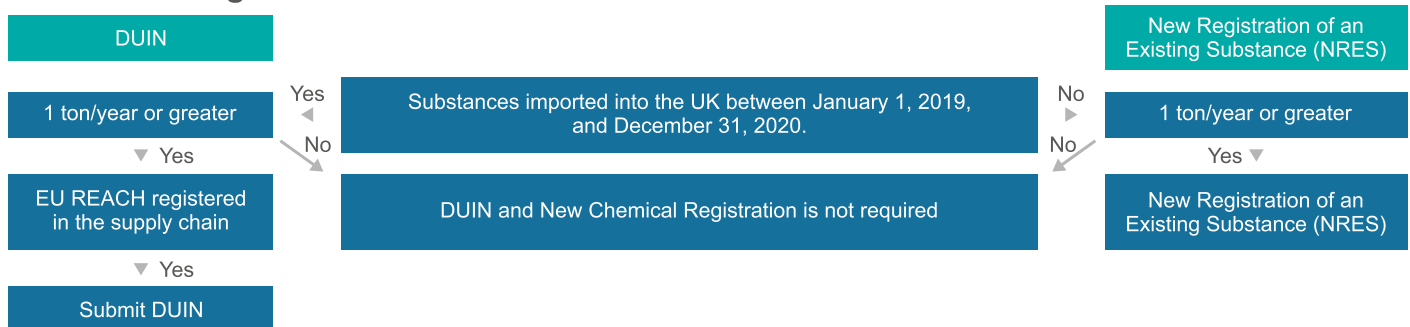


## UK REACH Services

### Background of UK REACH

On January 1, 2021, the UK established its own system of chemical regulation management, known as UK REACH. This regulation applies to any chemical substance manufactured or imported to the UK in 1 ton/year or greater. If a substance had an existing EU REACH registration before the end of the transition period, a Downstream User Import Notification (DUIN) may need to be considered. Registering a new chemical substance for the UK will require full registration before manufacturing or importing activities can begin in the UK. Please note, UK REACH only applies to England, Scotland and Wales. Northern Ireland is governed by EU REACH.

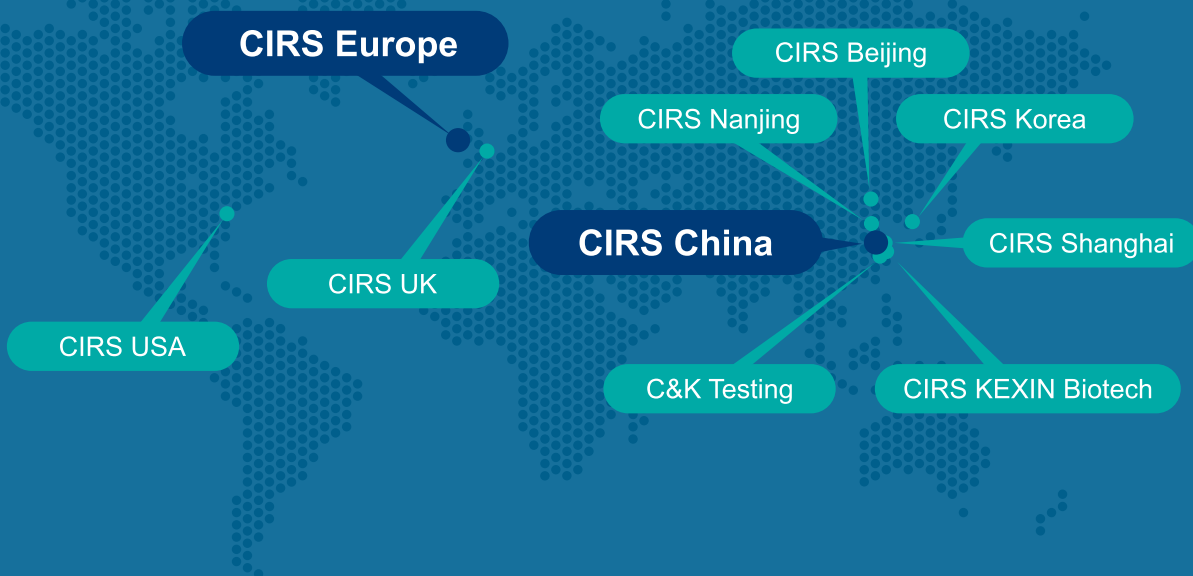
