

MEE Order 12 (China REACH) Services

➤ What is MEE Order 12?

- The revised Measures for the Environmental Management Registration of New Chemical Substances (MEE Order 12) was implemented on January 1, 2021.
- New chemical substance notification must be submitted before the substance is manufactured or imported into China.
- Foreign companies need a local Chinese agent to submit a new chemical substance notification.

➤ What is a New Chemical in China?

A new chemical substance is defined as one that is not listed in the Inventory of Existing Chemical Substances in China (IECSC) and therefore is required to comply with MEE Order 12, also known as China REACH.

➤ Who can register under China REACH?

A company that introduces a new chemical in China can register under China REACH this includes:

- A Chinese manufacturer;
- A Chinese importer; and
- A foreign exporter (by appointing an only representative (OR)).

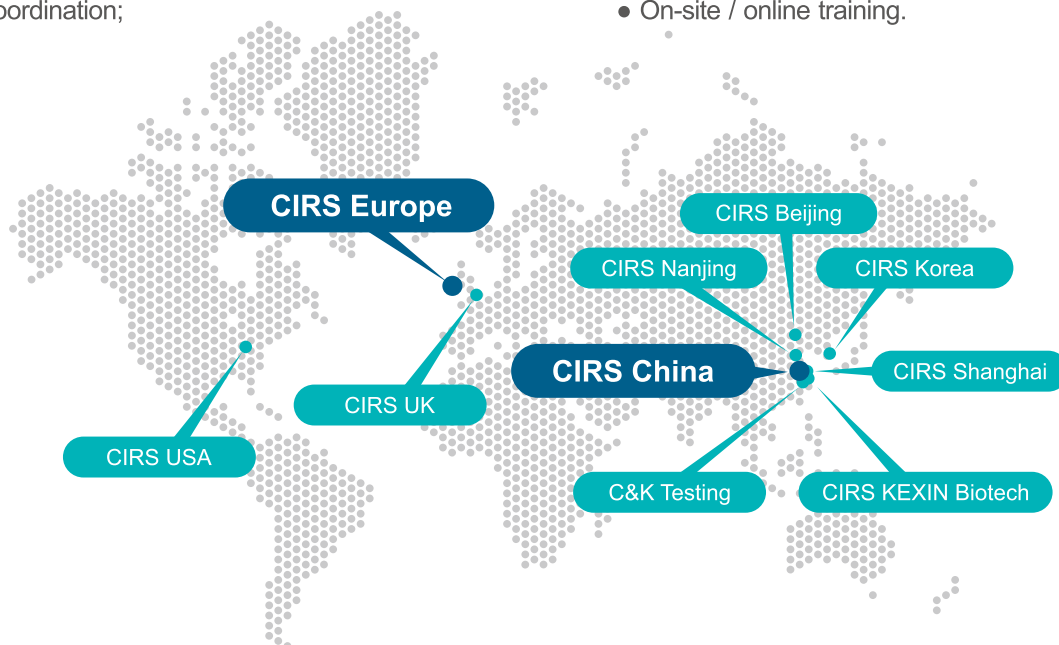
